Inland Revenue can get your refund to you faster by direct crediting instead of posting you a cheque.

The advantages are:

- you receive your refund(s) faster
- you don't have to deposit a cheque at a bank
- your funds are available immediately
- it's quick and easy.

If you choose the direct credit option, we'll send you a notice telling you the amount of the refund, the date we credited it to your account, and the number of the bank account it has been paid into.
